#1 Mini-Wakan State Park & Shelter:

Turn North off Hwy 9/71 at Hy-Vee. Travel North to 140th Street then left. (140th Street becomes 240th Avenue). Take 240th Avenue along the West side of Big Spirit Lake to 100th Street (Hwy 2, the Iowa/Minnesota state line) and turn right. Travel past the fishing catwalk and turn right at the park entrance and travel to the shelter house.

#2 Alex and Chris Oponski Home: *Alex serves as the treasurer for the Spirit Lake Protective Association & Mini-Wakan Restoration Project*

10880 240th Avenue, Spirit Lake. Turn North off Hwy 9/71 at Hy-Vee. Travel North to 140th Street then left. (140th Street becomes 240th Avenue). Take 240th Avenue along the West side of Big Spirit Lake to 10880 240th Avenue.

#3 Twetten's Interiors Studio:

Designer-Twetten's Interiors; Builder- Dau Construction
1005 18th Street, Spirit Lake. Located on Hwy 9/71 immediately West of the new Dickinson County Courthouse.

#4 Matt and Angie Mayer Home:

25817 169th Street, Spirit Lake. Take Hwy 9/71 East past Kum & Go, turn right on to 250th Avenue. (Camp Foster Rd/M-56). Follow to 169th Street (Arthur Heights, South entrance) and turn right. The home is the fourth home on the left.

#5 Don and Barb Pierson Home:

Designer-Twetten's Interiors; Builder- Rabel Construction
2005 Lakeshore Drive, Okoboji. Turn West off Hwy 71 on to Lakeshore Drive at the Mau Marine/Smith's RV intersection. Travel West to 2005 Lakeshore Drive located on the left.

#6 Jerry and Sandy Twetten Home and Garden:

Designer-Twetten's Interiors; Builder- Rabel Construction
6505 Lakeshore Drive, Okoboji. Turn West off Hwy 71 on to 170th Street, (also known as County Home Road/Wild Rose Inn corner) to Lakeshore Drive. Turn right and follow to 6505 Lakeshore Drive located on the left.

#7 "Earth Mother Gardens": *Master Gardner-Janice Adams*
Ron and Janice Adams, 15229 215th Avenue, Spirit Lake. Take Hwy 9 West past Indian Hills Golf Course to 210th Avenue, turn South and go to the stop sign. Turn left on to 215th Avenue and follow to 15229 215th Avenue located on the right.

#8 Jacob and Jeanni Stahl Condominium:

Designer-Twetten's Interiors
15110 215th Avenue, Unit #11, Spirit Lake. Take Hwy 9 West past Indian Hills Golf Course to 210th Avenue, turn South and go to the stop sign. The complex is located on the North side of the road.

#9 Gull Point Park & Shelter:

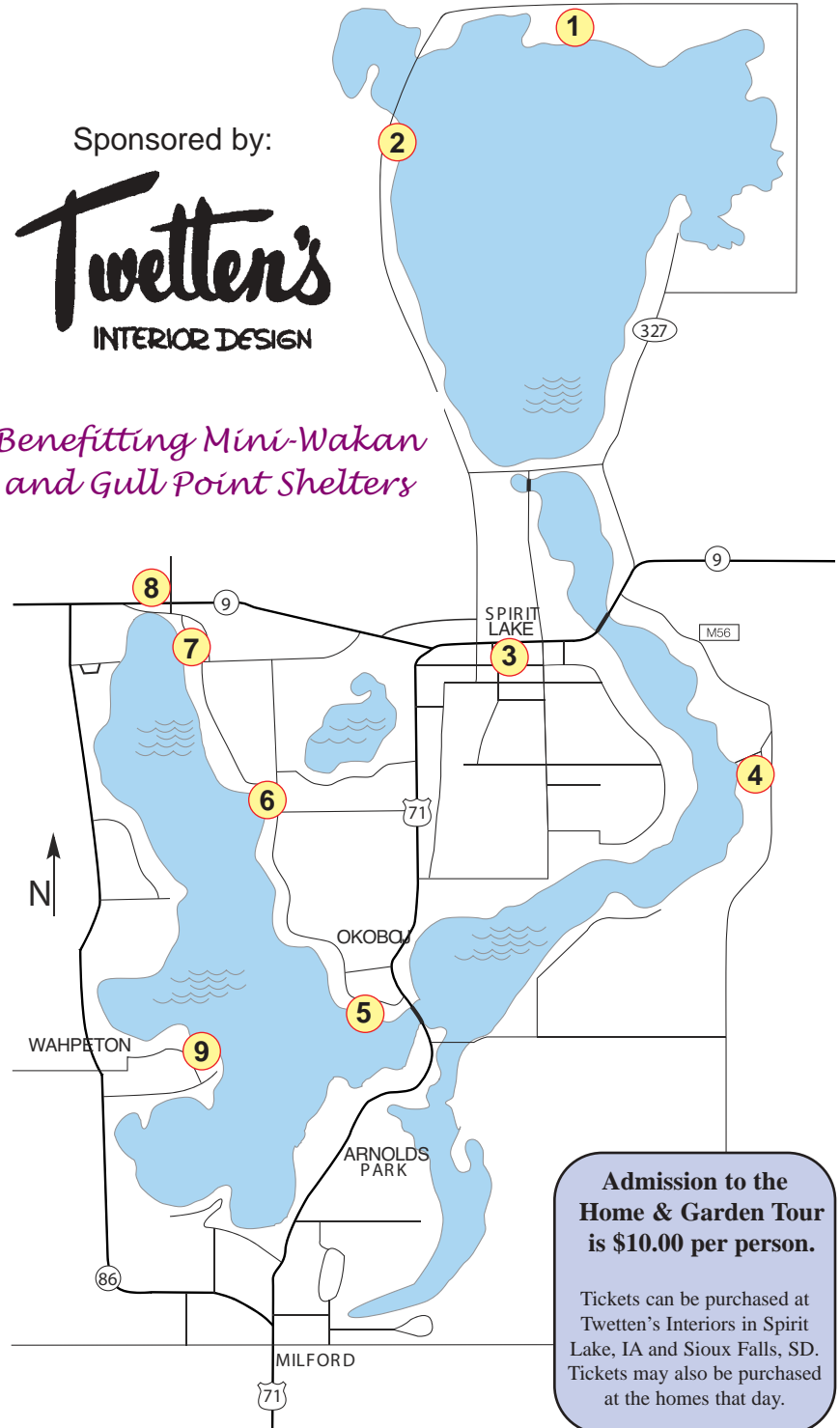
Not an official stop due to events being held
